Description	CD20 is a 33-37 kD, four transmembrane spanning protein, also known as B1 and Bp35. CD20 is expressed on pre-B-cells, resting and activated B cells (not plasma cells), some follicular dendritic cells, and at low levels on a T cell subset. CD20 is heavily phosphorylated on activated B cells and malignant B cells. Homo-oligomeric complexes of CD20 are thought to form Ca <sup>2+</sup> conductive ion channels in the plasma membrane of B cells. The CD20 molecule is involved in B-cell activation and is associated with various Src family kinases (Lyn, Lck, Fyn). It exists in a complex with MHC class I and II, CD53, CD81, and CD82.

For flow cytometric staining, the suggested use of this reagent is 5 $\mu$ L per million cells in 100 $\mu$ L staining volume or 5 $\mu$ L per 100 $\mu$ L of whole blood. It is recommended that the reagent be titrated for optimal performance for each application.

Application Notes	The epitope recognized by clone 2H7 has been mapped to the sequence YNCEPANPSEKNSPST which lies in the large extracellular loop of human CD20. Additional reported applications (for the relevant formats) include: immunoprecipitation <sup>4</sup> and immunohistochemical staining of acetone-fixed frozen sections <sup>5</sup> .


