The clinical interpretation of any staining or its absence should be complemented by morphological studies and proper controls and should be evaluated within the context of the patient's clinical history and other diagnostic tests by a qualified pathologist.</p>

<b>Immunogen</b>	This monospecific polyclonal antibody was raised against a peptide sequence derived from the C-terminus of the mouse keratin 5 protein.
<b>Formulation</b>	Phosphate-buffered solution + 0.03% Thimerosal.
<b>Preparation</b>	The antibody was purified by peptide affinity chromatography.
<b>Concentration</b>	1.0 mg/mL
<b>Storage &amp; Handling</b>	When stored at ≤ -20°C, product is stable until the date shown on the label. Avoid repeated freeze-thaw cycles to prevent denaturing the antibody. If thawed and stored at 2-8°C, product is stable for 24 months from the date of thaw or until the expiry date on the label, whichever comes first.
