Description CD11c is a 145-150 kD type I transmembrane glycoprotein also known as integrin αx and CR4.

CD11c non-covalently associates with integrin β2 (CD18) and is expressed on

monocytes/macrophages, dendritic cells, granulocytes, NK cells, and subsets of T and B cells. CD11c has been reported to play a role in adhesion and CTL killing through its interactions

with fibrinogen, CD54, and iC3b.

Formulation Phosphate-buffered solution, pH 7.2, 0.09% sodium azide, 0.2% (w/v) BSA (origin USA), and a

stabilizer.

Preparation The antibody was purified by affinity chromatography and conjugated with Pacific Blue™ under

optimal conditions.

Concentration 400 µg/mL

Storage & Handling The antibody solution should be stored undiluted between 2°C and 8°C, and protected from

prolonged exposure to light. Do not freeze.


